Background

Since its establishment, the ministry has held an important position in the areas of legislation and providing legal and professional services.

The Ministry of Justice's vision for the future is the rule of law and access to justice across the country, while the Ministry's strategic goal is to strengthen the justice system and provide quality justice and legal services to the people in a balanced manner throughout the country.

Therefore, the Ministry of Justice has adjusted its budget based on three programs (legislative affairs, legal services, and administration and management).
