#### Introduction

The position of leadership of the Islamic Emirate of Afghanistan is 1444/2/11LHC. On the basis of order number (400) the ministries and independent directorates have been entrusted with the task to submit a monthly report on their activities to the office of the leadership of the Islamic Emirate of Afghanistan on a regular basis.

According to the order of the above number of the position of I.E.A, the quarterly report of the Ministry of Justice, which includes the proceedings from (1444/4/1 LHC) to (1444/6/30 LHC) and it is presented with respect.

#### Summary of the report

The Ministry of Justice had planned all (48) major activities in the second quarter of the year (1444), of which (22) activities were completed, which resulted in achievements.

It is worth mentioning that (14) activities are being implemented and have progressed by a certain percentage, (0) activities have started and progressed by a certain percentage, but due to some problems, they are not being implemented for now. Also, (12) activities have not been started within one quarter due to obvious reasons, the statistics of which are presented in the table below.

On average, the implementation percentage of the activities reaches (59.2) percent in a quarter and (15.5) percent according to the annual plan.
