Introduction

Pursuant to the provision of decree number (400) dated 11/02/1444 (07/09/2022), of his Excellency Supreme Leader of Islamic Emirate of Afghanistan, all ministries and independent administrations are obliged to prepare the report of their performances in a quarterly basis whose first quarter should initiate from the first month of the lunar calendar (Moharram al haram) to the end of the third month of lunar calendar (Rabi al Awal) of the year 1444 (2023), encompassing their activities during these months and proceed likewise and present them to the office of his Excellency Supreme Leader.

In accordance with the provision of the above-mentioned decree, the quarterly report of Ministry of Justice which encompasses the activities of four months (Ramadan, Shawal, Dhul-Qi'dah and Dhu al-Hijjah) 1445 AH the same as (Hamal, Sawr, Jawza and Saratan) 1403, has been prepared and is hereby respectfully presented.

A Summary of Report

Ministry of Justice has planned a total of (68) major activities in four months (Ramadan to Dhu al-Hijja) of the year 1445 (2023) from which (37) activities have been implemented within four months (Hamal, Sawr, Jawza and Saratan) of the fiscal year 1403 (2024) and as obtained major achievements.

It is worth mentioning that (25) activities are under the implementation and progressed to certain percentages and execution of (0) activity has commenced and proceeded to certain percentage, however, owing to some impediments their realization process has been suspended for the time being. Likewise, the realization process of (6) activities has not started within one quarter due to some specific problems the statistics of which has been presented in the following table:

The average percentage of implementation of current affairs according to the plan in four months reach (74.68) percent and according to the annual plan it reaches (24.35) percent.
