Introduction

According to the decree number (400) dated 1444/2/11, The leadership of the Islamic Emirate of Afghanistan, independent ministries and directorates are obliged to report its activities on a quarterly basis, which of course includes the first quarter from the beginning of the month of Muharram until the end of the month of Rabi 1 of 1444 and continues in the same way, Submit to the office of the leadership of the Islamic Emirate of Afghanistan.

According to the guidance of the ruling number of the above authority, now the quarterly report of the Ministry of Justice, which includes the proceedings from the date (1st of Muharram al-Haram) to (the last of Rabi 1), is presented in order and respect.

Summary of the report

The Ministry of Justice had planned a total of (48) major activities in Rabi 1 of 1444, including (23) activities and achieved major achievements by realizing them. It is worth mentioning that 13 activities are being implemented and have progressed to certain percentages, the implementation (0) of the activity has started and has progressed to certain percentages, but due to some problems, the process of its realization has been delayed for now. Also, the process of realizing the number of (12) activities has not started during one quarter due to specific reasons, the statistics of which are presented in the table below.

The average percentage of implementation of activities according to the plan during a quarter is (60.3) percent and according to the annual plan it reaches (15.79) percent.
